RESOLUTION 2020-15 FISCAL YEAR 2020 BUDGET AMENDMENT

A RESOLUTION OF THE CITY OF PALM COAST, FLORIDA, AMENDING THE FISCAL YEAR 2019-2020 BUDGET RELATING TO GENERAL FUND REVENUES AND EXPENDITURES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR IMPLEMENTING ACTIONS AND PROVIDING AN EFFECTIVE DATE

WHEREAS, on November 15, 2019, City Council approved Resolution 2019-140, a resolution of support of higher education in the City of Palm Coast; and

WHEREAS, therein the City Council recognized that in order to sustain the City's high quality of life, it is critical that higher education opportunities be readily available to the City's residents and to the residents in surrounding areas; and

WHEREAS, employers and educators have identified the medical field as a fast-growing and critically important market sector for the entire Northeast and Northcentral Florida region; and

WHEREAS, in order to meet regional workforce needs and train the graduates of the future, the University of North Florida (UNF) is undertaking an initiative called "MedNEX," the nation's first comprehensive, university-based medical nexus; and

WHEREAS, a major component of the UNF MedNex initiative involves the establishment of a presence in the City of Palm Coast; and

WHEREAS, the City of Palm Coast desires to work closely with UNF and a host of other public and private-sector stakeholders to bring such higher educational opportunities to its residents and individuals throughout Flagler County and adjacent counties

WHEREAS, the City Council of the City of Palm Coast finds it necessary to amend the Fiscal Year 2020 budget for the Genereal Fund by \$1,500,000 towards the UNF MedNex initiative by transferring funds from the General Fund-Reserve to General Fund-Non-Departmental.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PALM COAST, FLORIDA, AS FOLLOWS:

SECTION 1. BUDGET AMENDMENT. The City Council of the City of Palm Coast hereby amends the Fiscal Year 2019-2020 budget for the General Fund by \$1,500,000 to \$41,635,081, as depicted in Exhibit "A", which is attached hereto and incorporated herein.

SECTION 2. SEVERABILITY. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this Resolution are severable, and if any phrase, clause, sentence, paragraph or section of this Resolution shall be declared unconstitutional by the valid judgment or decree of a court of competent jurisdiction, Resolution 2020-15

such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Resolution.

SECTION 3. CONFLICTS. All resolutions or parts of resolutions in conflict with any of the provisions of this Resolution are hereby repealed.

SECTION 4. IMPLEMENTING ACTIONS. The Mayor, or designee, is hereby authorized to take any actions necessary to implement the action taken in this Resolution.

SECTION 5. EFFECTIVE DATE. This Resolution shall become effective immediately upon its passage and adoption.
