

To Our Residents:

This is our Annual Progress Report for 2013 – an overview of the City of Palm Coast's accomplishments, achievements and forward progress based on the goals set by the Palm Coast City Council. The report includes a section on each of the six goals: Expansion, Economic, Finance, Environmental, Quality of Life, and Workforce Talent.

Plus, it includes a summary of the annual Citizens Survey and a special report on the year's greatest unforeseen challenge – the Starlight Tornado – and how the City rose to that challenge to provide a quick and comprehensive response and follow-up to aid in the recovery.

There is much to be proud of as we review 2013! The economy continues to improve in Palm Coast, with positive trends such as increases in taxable sales and visitor spending, more jobs, and many new construction projects – both residential and commercial. While continuing to grow and strengthen, the City has been able to keep property taxes at the same level and still accomplish many big projects, earn awards for excellence and improve the quality of life for residents.

This past year was one of transition and setting a foundation as we chart a course for the year ahead and beyond. Planning and design for a number of capital projects to be started (and, in some cases, finished) in 2014 were completed in 2013, and we are very excited to be moving forward with the following:

- Palm Coast Parkway 6-Laning, from Cypress Point Parkway/Boulder Rock Drive to Florida Park Drive – to include pedestrian/bike paths on both sides of Palm Coast Parkway
- Bulldog Drive Improvements including reconstruction, drainage and intersection
- Palm Harbor Parkway and Old Kings Road extensions in preparation for new I-95 interchange
- Multi-Use Pathways along Seminole Woods Boulevard and Matanzas Woods Parkway
- M-3 Surface Water Control Structure replacement (weir on Belleaire Waterway)
- Zero Liquid Discharge water treatment plant at Water Plant 2
- Long Creek Nature Preserve, Phase 1
- Renovation of James F. Holland Memorial Park, Phase 1
- Rehabilitation of the College Waterway Bridge
- Gateway Improvements to include signage and landscaping
- Phase 1 of new City Hall at Town Center

In addition to planning and design for these exciting projects, the City completed a number of major projects benefitting the residents of Palm Coast this past year – everything from roadway improvements and a new pathway on Pine Lakes Parkway North, to major stormwater system upgrades in Lehigh Woods to major beautification of the medians on Palm Coast Parkway West near U.S.1 and on Belle Terre Parkway from Ponce de Leon Drive to Royal Palms Parkway. The Fire Department offered a variety of community programs to keep residents safe, drainage improvements were made, and the Parks & Recreation Department expanded special events and recreation programming to serve all residents, toddlers to seniors. Many of those projects were completed using in-house City crews, saving taxpayer dollars.

The City prides itself on excellence! The City, its departments and employees won a number of awards in 2013, as outlined in Workforce Talent. We are constantly striving to improve, through training, to better serve you – our citizens!

As you read the 2013 Annual Progress Report, please reflect on how you Found Your Florida in Palm Coast. We think you'll agree Palm Coast is a great place to live, work and play!

Starlight Tornado

Meeting An Unforeseen Challenge Plan. Train. Prepare. Respond

The City of Palm Coast put its emergency preparations to the test in December 2013, when the Starlight Tornado brought a 1.5-mile trail of destruction to the B, C and F sections of Palm Coast. In all, seven homes were destroyed and another 234 homes were damaged, adding up to \$7.27 million in damage. Thankfully, no one was injured or killed and the tornado staved clear of Town Center, where the Starlight Holiday Parade wrapped up early due to the approaching storm. The City executed a quick and comprehensive response in the minutes, hours and days after the tornado. After ensuring residents' safety, City teams helped our citizens recover by providing debris cleanup, damage assessment, street-sign replacement, and a streamlined permitting and inspections process for emergency repairs. City Customer Service representatives went door-to-door with the American Red Cross to assist residents in



Annual Survey Results

The National Citizen Survey Tracking Our Progress

The National Citizen Survey (NCS) provides a statistically valid overview of resident opinions about community quality of life, City services, civic participation and unique issues of local interest. The survey findings further allow us to compare ourselves against a benchmark of 500 cities and communities across the United States.

The NCS report is about the "livability" of Palm Coast. The phrase "livable community" is used to evoke a place that is not simply habitable but that is desirable. It is not only where people live, but where they want to live.

The National Citizen Survey Findings How Are We Doing?

The Natural Environment makes Palm Coast a very desirable community in which to live.

Across Community Characteristics, Governance and Participation, ratings for the Natural Environment were high. Many aspects of the Natural Environment were similar to the benchmark and Palm Coast's cleanliness was above the benchmark. Ratings were high for services such as garbage collection, recycling, and yard waste pick-up and participants frequently participated in conserving water, recycling, and making their homes energy efficient. When asked what were the most important attributes in promoting Palm Coast were and how Palm Coast compared to previous communities they had lived in, cleanliness, beaches, climate, beauty and trails were the most frequently cited answers.

Participants value their Safety.

About 7 in 10 respondents feel safe overall and almost all participants feel safe in their neighborhood. Safety aspects of Governance were rated highly by a majority of participants and were similar to the benchmarks. More participants in Palm Coast are prepared for emergencies with stocked supplies than in jurisdictions across the nation. Most participants had not been a victim of a crime or had reported a crime to police in Palm Coast; both were these ratings were similar to the benchmark.

Recreation and Wellness are important to participants.

A majority of participants gave high ratings for Community Characteristics surrounding Recreation and Wellness (such as fitness opportunities, recreation opportunities and health and wellness). Ratings for recreation opportunities were also trending upward compared to the 2012 survey. While City parks, recreation programs and health services were trending lower compared to 2012, they were still rated highly by a majority of participants and were similar to the benchmarks. Participation in Recreation and Wellness is high in Palm Coast. About 8 in 10 participants have visited a City park, eaten at least 5 portions of fruits and vegetables a day and participated in moderate to vigorous physical activity. About three-quarters of respondents cited recreation and an active lifestyle as an "essential" or "very important" attribute in promoting Palm Coast.

The Economy still has room for improvement.

While many ratings for the Economy were stable over time and similar to the benchmark, there were still aspects that could see improvement. Aspects such as overall economic health, employment opportunities and Palm Coast as a place to work were below the benchmark and rated positively by less than half of participants. Ratings for economic development were also below the benchmark and about one-third of participants rated it positively. But, some economic ratings were positive. Particularly, ratings for businesses and services in Palm Coast were rated highly by over half of participants, a rating that was higher than in 2012. Most participants rated Palm Coast as a place to visit highly and almost all participants (98%) purchased goods or services in Palm Coast.

Planning Ahead Anticipating Needs


To anticipate the need for additional services and infrastructure to provide opportunities for mixed use development with goods, services, and employment.

Planning Ahead

The Palm Coast City Council has adopted a multi-year Capital Improvement Plan (CIP) that provides a safe and functional community and allows for growth. The plan gives clear direction for expansion, maintenance and replacement of the City's infrastructure. The CIP is updated annually to track and plan for all capital projects and to allow staff to plan for future budget years.

A team of City employees meets weekly to manage the CIP. Each year, when the budget is adopted by City Council, the team schedules that year's projects and extends other projects into future years. The timeline is adjusted as projects progress, issues arise and priorities change.

Pictured at right are new wells, added in the recent wellfield expansion. Shown below are a roadway pipe project (bottom left) and reconstruction of a water control structure (bottom right).







Maintaining And Improving From Design To Construction



The Engineering and Stormwater Department completed reconstruction of three of the City's 31 water control structures in 2013. Pictured above is the Three Sisters Water Control Structure Complex. Engineering and design were done by City employees, resulting in significant savings. Contractors for construction were chosen through competitive bids, with two of the projects completed by local contractors. Also this past year, Engineering and Stormwater replaced eight of the City's 145 pipes that drain roadways into saltwater canals.

The Engineering and Stormwater Department and the Public Works Departments collaborate to maintain and replace much of the City's drainage system, saving taxpayer dollars by doing the engineering and the construction in-house. In 2013, the two departments worked together on these projects:

- Design of 101 of the system's nearly 1,600 roadway pipe crossings with replacement of nearly 4,000 feet of pipe;
- Design of 19 of the system's 353 intersection valley gutters being replaced. Following the CIP, half of those crossings have been replaced;
- Design and replacement of a major roadway pipe crossing on Pritchard Drive; and
- Design and regrading of more than 57 miles of Palm Coast's 1,100 miles of roadside swales.

Expansion

Capital Improvement Making A Great Community Better



PINE LAKES PROJECT: The section of Pine Lakes Parkway from Palm Coast Parkway North to Belle Terre Parkway including paving the shoulders, adding left turn lanes, moving utilities underground, adding new water and 10-foot-wide multi-use path (pictured below right).

BEAUTIFICATION: Two major median landscaping projects were done in 2013 - along Belle Terre Parkway (pictured above) from Ponce DeLeon Drive to Royal Palms Parkway and along Palm Coast Parkway (western end) from Brushwood Drive to U.S. 1. On Belle Terre, new trees, plants and sod were added, and irrigation was installed. The Palm Coast Parkway project included new trees, shrubs and sod, as well as landscape lighting, a sign upgrade, and irrigation. In addition, red paver concrete median tips were put in at the intersections on Palm Coast Parkway and the turn lane at the west entrance to St. Joe Plaza was improved.

SIX-LANING PREP: 2013 was an important year for the Palm Coast Parkway six-laning project, with design and permitting being completed. The project includes widening of approximately 1.23 miles of Palm Coast Parkway from Cypress Point Parkway/Boulder Rock Drive to Florida Park Drive with the addition of pedestrian/bike paths on both sides of Palm Coast Parkway. The roadway was previously four lanes wide. The existing bridge over Interstate 95 was constructed to accommodate a six-lane roadway, so no new construction will be needed. Lighting and landscaping will be upgraded, improving the appearance as well as function. Construction will be March 2014 to December 2015.

Adding new facilities for residents and improving existing facilities is a top priority for the City of Palm Coast. Areas targeted through the Capital Improvement Plan (CIP) include parks, multi-use paths, streets, City facility construction/renovation, and beautification such as landscaping and signage. Long-range planning is utilized to allow for budgeting of higher-cost projects over multiple years. Many projects were completed in 2013, and the City laid the groundwork for many others. Here are some highlights.

PRESERVING NATURE: Design and permitting for the new Long Creek Nature Preserve were also finalized was widened and resurfaced, with additional work in 2013. Phase I construction for the nature preserve, located on Palm Harbor Parkway adjacent to the College Waterway Bridge, will include construction of a path stormwater piping and structures, and constructing a and boardwalk to new canoe/kayak launches into Long Creek and College Waterway, installation of shoreline stabilization along College Waterway, construction of a fishing pier along College Waterway with floating dock for boat mooring, and an entrance to the site with a parking area. The project will provide access to the City's saltwater canal system, and eventually facilitate access to the Pellicer Creek Aquatic Preserve and other regional attractions.



Continuing To Expand Within & Beyond Our Borders

Utilities

The Utility Division of the Palm Coast Public Works Department works hard to provide award-winning service to residents - and also to plan ahead for that same level of service for future residents and surrounding communities. Construction began in 2013 on a new Zero Liquid Discharge plant to comply with state regulations regarding the disposal of concentrate produced through the water treatment process at Water Plant 2 on Citation Boulevard. Implementing a ZLD process at Water Plant 2 will treat and recover up to 1.2 million gallons of water per day – which will be blended with the plant's finished water to increase distribution capacity and add to the City's water supply in an economically feasible, environmentally responsible way. The new ZLD will begin operations in late 2014. Construction of the tank portion of the project is pictured at right.



Also in 2013, Utility completed the design and permitting of the Beachside Sewer System Phase 1. These improvements will allow for expansion on the beachside. They include a new pump station at Hammock Dunes Bridge and State Road A1A and a force main system to convey wastewater to the treatment facility on Utility Drive. The project is made possible by an interlocal agreement between the City and the County that calls for the City to supply bulk wastewater service for the Beverly Beach Service Area. With the agreement, the County won't need to build a new wastewater treatment facility to replace its aging plant on the barrier island. Removal of the beachside facility also benefits the environment.

The division also completed the second phase of the expansion of the City's wellfields. Twelve new wells were constructed to provide additional water – up to 3 million gallons per day – at Water Plant 3. Six of those wells have stand-by generators so water can be produced if power service is lost.

Transportation



To prepare for future growth, the Community Development Department with the assistance of the City's Infrastructure Team initiated the City of Palm Coast's transition into the Volusia Transportation Planning Organization (TPO) during 2013. The Volusia TPO boundaries were expanded to include Palm Coast, and the City of Palm Coast was given a voting seat with the organization. The TPO name changed from the "Volusia TPO" to the "River to Sea TPO" to better represent the addition of Palm Coast, Bunnell and Flagler County. At left, the TPO Board is pictured touring Palm

Key accomplishments with the transition included ensuring the City's transportation project priorities were not negatively impacted, adjusting the TPO schedule so it didn't conflict with Palm Coast City Council meeting dates, and securing fair representation to the TPO Board and subcommittees.

Economic



To develop and maintain a strong economy by supporting the growth and development of new and existing businesses while creating an environment to attract new companies that align with our values.

The City of Palm Coast works to expand business opportunities that foster a strong local economy. Positive trends continued in 2013, with rising employment, taxable sales, median home values, capital investment, visitor spending and new construction.


Prosperity 2021 serves as the City's strategic economic development plan. Its primary goals:

The City issued 263 single-family residential permits during 2013, a 70-percent increase over the year before. The construction value was \$71.6 million. There were 230 new commercial construction permits issued, with a construction value of \$30.9 million

The City, in partnership with local sports clubs and the Flagler Tourist Development Council, hosted 17 sports tournaments in 2013 with an estimated visitor spending of \$3 million.



Key to Prosperity 2021 is the Palm Coast Business Assistance Center. Established in 2011, the BAC is a unique partnership between the City of Palm Coast and the Florida Small Business Development Center hosted by the University of Central Florida. The BAC provides personalized assistance in starting and growing businesses in Flagler County, at no cost to businesses. Since the center's inception, BAC clients have increased their sales by more than \$4 million and invested \$3.2 million in capital expenditures in Palm Coast. BAC clients return \$97 to the local economy for every \$1 of taxpayer money invested in the BAC. This year, the center added another certified business analyst to its staff, expanding its ability to assist even more local businesses.



The City supports the economic development efforts of the Flagler County Department of Economic Opportunity and the Flagler County Chamber of Commerce. Successes yielded this year include a \$600,000 U.S. Environmental Protection Agency brownfields grant and the relocation to our area of both AVEO Engineering and GIOIA Sails.





In 2013, the BAC hosted a five-part Lunch n Learn business series, "Fearless and Focused: Women in Business," along with two Business Outreach programs geared toward minority business owners.

"How Successful People Think" was the theme of the 3rd annual Palm Coast BAC Expo, presented by the BAC, the Florida Small Business Development Center at UCF, and Flagler County Chamber of Commerce.



Financial Excellence

Leveraging Our Financial Strengths

To leverage our financial strengths while ensuring the city remains committed to fiscal responsibility and delivering value-added services to residents and businesses.

The City's strategies to accomplish this goal include diversifying our revenue sources and increasing efficiency through enhanced operations and technological advancements. The Strategic Action Plan is the guiding policy document for City Council and City staff. Each year the budget is driven by the mission statement and goals contained within the Strategic Action Plan.

Financial Excellence Awards

The Government Finance Officers Association of the United States and Canada (GFOA) presented a Distinguished Budget Presentation Award to the City of Palm Coast, for the Annual Budget beginning October 01, 2012. In order to receive this award, a governmental unit must publish a budget document that meets program criteria as a policy document, as an operations guide, as a financial plan, and as a communications device. This is the tenth consecutive year that the City of Palm Coast has received this award.



The City also received the GFOA Certificate of Achievement in Financial Reporting for the 12th consecutive year.

Grants

Firehouse Subs donated skid packages for two Fire Department vehicles, and a \$96,000 grant was received to purchase 15 Lifepak cardiac monitoring units. St. Johns River Water Management District provided a \$494,800 grant for the Water Plant 3 Concentrate Treatment System. Florida Inland Navigation District (FIND) gave \$80,000 toward the Annual Intracoastal Waterway Cleanup and for design of Long Creek Nature Preserve. The City continues to participate in the Community Development Block Grant and Neighborhood Stabilization Program for housing and rehab assistance to residents.

Rolled-Back Millage Rate Adopted

During this year's budget process, the City Council reduced the City millage rate to the rolled-back millage rate, which will result in the same amount of property tax collection as the previous year. This will allow the City to maintain the same level of service to the citizens of Palm Coast, while maintaining the third lowest millage rate for cities our size (population between 60,000-90,000) in Florida.




The Association of Public Treasurers of the United States & Canada presented the City of Palm Coast with the Association's Investment Policy Certificate of Excellence Award. The Investment Policy was revised and submitted to the association for the award based on the upgraded policy. This shows the City's continued commitment to sound financial policy.

Our Tax Dollars - Ad Valorem Receipts

Property taxes from citizens have declined from a high of \$20 million in fiscal year 2008 to \$15 million in fiscal year 2014. Total taxes collected have remained flat for the last four consecutive years. This has been accomplished through reorganizing City functions, a reduction in the workforce of nearly 35 tax supported positions since fiscal year 2009, and various cost containment programs.

Environmental

Reuse and Reduce Thinking of our Future

To blend our residential and commercial properties with our "City of Parks and Trails" image to create a sustainable framework of visual appeal while caring for our land, water, air and wildlife.

Our commitment to environmental sustainability is a keystone to the balance of the natural environment and the growth of our beautiful City. We continue to look for more opportunities to conserve our precious resources while being fiscally responsible and sensitive to the uniqueness of our community.

Expanding Reuse

Through the use of in-house resources, the reclaimed water supply was expanded to Hidden Lakes subdivision, Holland Park, and S.R. 100. Use of reclaimed water for irrigation is a form of alternative water supply which replaces ground water or potable water for irrigation of residential and other public accessible areas.

The City has been implementing reclaimed water reuse projects since 1995. The implementation of reclaimed water reuse has significantly reduced potable water demands.

Saving Trees

In 2014, Palm Coast Parkway will be widened, bringing some much needed relief along our roadways. The widening will reach from Florida Park Drive to Cypress Point Parkway/Boulder Rock Drive and will have minimal encroachment into natural areas.

Through an innovative and extraordinary effort, 110 sabal palms have been relocated through in-house resources to Waterfront Park (30 trees), Indian Trails Sports Complex (72 trees), and Palm Coast Parkway west (8 trees).


 Since 2009, the City of Palm Coast has offered free educational program to Flagler Schools.



Ellerin's photo is being displayed in City Offices at City Marketplace this year. 
