Public Invited To Two Events Honoring Former City Council Member Frank Meeker

In honor of former Palm Coast City Council Member Frank Meeker who died in July, the City of Palm Coast will be dedicating a soccer field at Indian Trails Sports Complex and a tree and garden at Central Park in Mr. Meeker's honor. The public is invited to both dedications.

The soccer field dedication at the Indian Trails Sports Complex is being held on Tuesday, September 27th at 6pm. Field 3 at the complex will be dedicated in Mr. Meeker's honor. The new sign will be unveiled as Mayor Netts and others speak.

The dedication of the Crepe Myrtle tree and garden at Central Park will be held on Tuesday, October 4th at 6pm, on the pathway around Central Park lake (near the southwest corner of the lake).

The City welcomes friends of Mr. Meeker to join the family and City officials at both events, as they honor Mr. Meeker for his dedication in public office and his passion for youth soccer as a well-loved youth soccer coach, mentor and volunteer.

Palm Coast City Hall - LEED Silver Certified



The U.S. Green Building Council certifies buildings to a Leadership in Energy and Environmental Design (LEED) rating, one of the most popular green building certifications worldwide. In the planning and design stage of City Hall in late 2014, the City decided to pursue LEED-certification. There are different levels of certification: Certified (lowest), Silver, Gold and Platinum (highest). We were just notified that City Hall has achieved a Silver rating, which is based on water and energy conservation along with reducing

greenhouse gas emissions. This is an achievement that the City is proud to have obtained. Without the impressive team of consultants, contractors, and staff, the City Hall LEED Silver certification would not have been possible. Intracoastal Waterway Cleanup – "Stache the Trash"

The 9th Annual Intracoastal Waterway Cleanup event, included 539 volunteers working together to "Stache the Trash". Volunteers collected 3,055.5 pounds of trash, the first year our collection reached over 3,000 pounds. After cleaning our precious waterways, paths and parks, volunteers brought their odd items to enter into the Most Unique F.I.N.D. contest, which included, amongst others, golf balls, a fire extinguisher and tape player. A big thanks for the generous funding from the Florida Inland Navigation District (F.I.N.D.) and our other fine sponsors, and thanks to the Florida Fish and Wildlife Conservation Commission Law Enforcement Officers for being our honorary judges for the 9th year in a row!





Our Parks and Recreation Department can report another successful Senior Games this year. There were a total of 259 participants from 54 cities around the state of Florida. Athletes competed in various events including archery, ballroom dancing, cycling, croquet, tennis, horseshoes, golf, pickleball, basketball, table tennis and swimming. 





Development Order issued for Tuscan Gardens

This 71.54-acre site located at the southwest corner of where Blare Drive intersects with Colbert Lane, was approved for a Development Order by the City Council on September 20, 2016. The contracted purchaser of the site and developer is Tuscan Gardens Group, LLC, with corporate offices in Orlando, who intend to develop a luxury senior living facility with 120 independent living units, 56 beds for memory care patients, 110 beds for assisted living patients. Construction is expected to start in approximately one month.





9th Annual Intracoastal Waterway Cleanup

On September 10, 2016, the 9th Annual Intracoastal Waterway Cleanup – What Will You F.I.N.D. event resulted in 3,055.5 pounds of trash and debris removed from the environment. Most of the volunteers attended the September 3rd Orientation event and hit the ground running on event day. Official Results:

539 Volunteers worked together to collect 3,055.5 pounds of trash. This is the first year that the collection measured over 3,000 lbs.

Odd items entered into the contest included golf balls, pick axe, fire extinguisher, tape player, signs, orange cone, and green inner tube. We deeply appreciate the time and dedication of the Florida Fish and Wildlife Conservation Commission Law Enforcement Officers for being our honorary judges for the 9th year in a row! The winner was the finder of a tape player.



Palm Harbor Golf Course Bunker Rehabilitation

Work has begun on the bunker rehabilitation at the City's Palm Harbor Golf Course with the bunkers on all 18 holes to be completed by mid-November. The purpose of this renovation is to replace the sand in the bunkers that has been contaminated over the years with debris and dirt and therefore do not drain properly. Reduced maintenance is also the goal here as some sand bunkers are being eliminated or reduced in size since bunker maintenance takes more time than mowing grass. The playability of the course will not be compromised as the City consulted with the original golf course architect who reviewed the plans and concurred with the bunker reduction plan. The course will also not be closed during this time. Arrangements have been made by Kemper Sports to play around the holes being worked on or temporarily shortening holes to a par 3. The course will be in great shape in time for the increased play that begins near Thanksgiving.

What should you do if you find baby wildlife? First thing that you do when rescuing orphaned wildlife is to make sure that it is actually abandoned. Wait at least 24 hours to make sure that the mother is not out hunting for food. During this period of time, you could be researching where your nearest rehabilitation center is. Sometimes we think that the animal is so cute that we can rehab it. Please leave the rehabilitation to the professionals. They are trained in the specific needs of the orphaned pet. They may decide to train you to care for the animal if they are crowded at that time.

Donation Opportunities: The *Flagler Humane Society Thrift Store* always accepts donations. They cannot take in any computers/printers or large appliances at this time. Call 386-597-2839 and leave a message. All proceeds from the sales go to directly care for the homeless pets of Flagler County.

Re: Week in Review

In the past week, the department responded to a total of 145 calls. There was one fire call. We responded to a cooking fire. A total of 98 EMS calls were logged and the balance was miscellaneous in nature. The drought index is at 218 out of a possible 800 and the fire danger is low.

We had our September Training otherwise known as our "Annual Combat Challenge" this week. Each firefighter goes through the evolution every September. The goals of this training are to work on improving personnel times from the previous year and improving air consumption. The evolution involves the fire fighter being in full gear while breathing air out of an air pack and going through drills. The drills include: going up 4 stories with hose on their shoulder, pulling up a hose from the ground, while on the roof, picking up the hose and going back down the 4-stories, performing a sledge hammer drill, pulling a "charged" (full water pressure) hose line, spraying water and then finish by dragging a 100-lb mannequin 50 feet. The Firefighters and Lieutenants had an eventful week of training!

Annual testing of our departments Ground/Portable ladders took place this week. They tested 526 feet.

The Chiefs returned home safely after a successful inspection trip of the twin engines in South Dakota.

Chief Beadle and Deputy Chief Forte assisted in teaching the current training for Active Shooter class this week.

Re: Week in Review

- The conversion from chloramines to free chlorine as the primary disinfection treatment procedure began this week and will continue through October 24th. During this time customers may notice an increase in the taste and odor of chlorine in their drinking water.
- The average water demand for this week was 7.596 million gallons per day. The average wastewater flow was 5.968 million gallons per day.
- Crews installed 11 new domestic water meters, 2 reuse meters and 9 new PEP tanks.
- There were a total of 35 calls after hours.
- This week there were 22 disconnects for non-payment.
- Staff performed smoke testing of the sewer collection system at Flagler County Airport.
- Water Distribution crews repaired 3 service lines, and tested/repaired 95 backflow preventers.
- Wastewater crews inspected via CCTV, 9,673 feet of gravity sewer and inspected 46 manholes. They also replaced 30 pep pumps, 34 floats and 9 cleanout caps.

• Water Distribution crews worked at Water Treatment Plant #2 replacing a leaking section

of 16" raw water main where it enters the meter vault. This required installing a well point system, removing the vault lid and cutting out the pipe in sections, removing concrete grout around pipe, installing new pipe and new connection fittings.

Palm Coast – City of Palm Coast Recreation Superintendent Alex Boyer is being promoted to Director of Parks & Recreation after serving as the Interim Director this summer.

He also has extensive experience as a soccer coach, serving as Director of the Girls Soccer Academy in the West Virginia Soccer Club and a coach with the Kentucky and West Virginia Olympic Development Soccer Programs. In 2015, he was named ODP Coach of the Year for West Virginia. He earned an advanced national license from the National Soccer Coaches Association of America, and is a member of Florida Recreation & Park Association.

A native of West Virginia, Boyer earned his Bachelor of Arts degree in physical education, with a concentration in sports management and marketing, from Marshall University and his Master of Science degree in recreation and sport sciences from Ohio University in Athens, Ohio. He and his wife, Shawna Boyer, have two young children, Lakyn and Tristan.

Since coming to work for the City of Palm Coast earlier this year, Boyer has worked to strengthen relationships with local sports organizations and has implemented a field rotation schedule at City parks to ensure the fields can be used by both local organizations and for sports tournaments.

"I've been an athlete since I was a kid – basketball, track, soccer – so recreation has helped shape my life. Recreation has given me leadership abilities, and I consider myself a coach more than anything," Boyer said. - 1. Provide the following:
- a. A narrative response to each Preliminary Review comment below.
- b. A narrative describing any additional changes made to the energy models between the Preliminary and Final Review phases not addressed by the responses to the review comments. The mandatory comments are perceived to reduce the projected savings for the Proposed design. If the projected savings increase substantially in the Final submission, without implementing any optional comments that may improve performance, a narrative explanation for these results must be provided.
- 2. The energy savings reported for exterior lighting do not appear to be substantiated. Exterior lighting accounts for 14% of the overall energy usage for the Baseline Case, which is higher than expected. Review the Baseline and Proposed inputs for the model to confirm that they conform to ASHRAE 90.1-2007 and LEED modeling protocol. Provide sufficient information regarding the energy inputs in the Section 1.4 Tables and an accompanying narrative to justify the reported energy savings. Confirm that the Proposed Case exterior lighting reflects the actual building design and the Baseline case reflects the allowed lighting power from the ASHRAE 90.1-2007 Section 9. Ensure that no credit is taken in the Proposed Design Case for lighting reductions on non-tradable surfaces. Additionally, additional lighting power allowance cannot be claimed in the Baseline model for surfaces that are not provided with lighting in the actual design and lighting fixtures cannot be double counted for different exterior surfaces. Provide additional documentation, such as photometric plans, to confirm that no credit was claimed for surfaces that are not illuminated in the design. Report the tradable and non-tradable surface lighting power separately (in units of Watts or Kilowatts) for both the Baseline and Proposed Case in Supplemental Table 1.4 and verify that these values are appropriately reflected in the model outputs and Tables EAp2-4 and EAp2-5.
- 3. Table 1.4 indicates that only one system type was included in the Baseline energy models. Additional HVAC system types should be specified in the Baseline building if any of the mandatory exceptions from G3.1.1 are applicable. For this building, it appears that exception (b) would apply to some of the air conditioning systems (for example, those serving electrical rooms and IDF rooms). Revise the Baseline energy model as necessary; update Table 1.4 and the form. If additional systems are not specified in the Baseline Case, provide a narrative and calculations to verify that they are not required.
- 4. Based upon the information provided in IEQp1: Minimum Indoor Air Quality Performance, it appears that Demand Control Ventilation should be modeled in some spaces per Section 6.4.3.9 (e.g. 152 Council Chambers, 152B Expanded Seating Area). Confirm that the occupant density for all spaces is less than 40 people per 1,000 square feet, or verify that Demand Control Ventilation is reflected in the Baseline Case for all spaces where required.
- 5. Insufficient information is provided in Supplemental Table 1.4 regarding VAV fan-powered terminals. For both the Baseline and Proposed Case, indicate in Table 1.4 the fan power per cfm for the parallel fan-powered boxes, the peak air flow as a percentage of design flow, and the minimum volume setpoints as a percentage of peak design flow, and verify that the Baseline Case is modeled in accordance with Section G3.1.3.14, or make any necessary revisions to the model.
- 6. It is unclear whether the Proposed Case HVAC system was modeled as designed because the fan nominal hp reported in the System Entered Values reports does not match the fan power indicated in the Air Handling Unit Schedule provided in PIf4: Schedule and Overview Documents (PIf4-3 PCCH Mech Schedules M6.101102-ro.pdf). Table G3.1.10 (b)(Proposed) requires that the model be consistent with the design documents. Update the model so that all HVAC system parameters (e.g. fan volumes, fan powers, efficiencies, heating/cooling capacities, etc.) are consistent with the design documents, update Supplemental Table 1.4 to reflect all changes made, and update the form to reflect any changes made.

7. The energy savings reported for fans do not appear to be substantiated because the Baseline and Proposed systems both have variable speed fan control, the Proposed Case fan power does not appear to be modeled per design, and there is insufficient documentation of additional measures that could be expected to lead to the 55% savings reported for the project. Review the Baseline and Proposed inputs for the model to confirm that they conform to ASHRAE 90.1-2007 and LEED modeling protocol. Provide sufficient information regarding the energy inputs in the Section 1.4 Tables and an accompanying narrative to justify the reported energy savings.

REVIEW COMMENTS THAT DO NOT REQUIRE A PROJECT RESPONSE, BUT MAY LEAD TO AN IMPROVED PERFORMANCE RATING IF ADDRESSED (Optional)

- 8. The Baseline and Proposed Case service water heating consumptions indicated in Tables EAp2-4 and EAp2-5 seem high based on the building type and the total water consumptions indicated in WEp1: Water Use Reduction. Additionally, the equivalent full load hours for service water heating are higher than expected for this type of building. Confirm that service water heating systems are modeled consistent with the requirements of ASHRAE 90.1-2007 Table G3.1.11. After making any necessary updates to the models, update Table 1.4.5 to report the service water heating parameters for both the Baseline and Proposed Case. If taking credit for low-flow fixtures, provide backup water heating calculations showing the fixtures consistent with those reported in WEp1, as well as estimations of the percentage hot water versus cold water flow, the delta T of the DHW system, and the anticipated hot water temperatures at the fixtures.
- 9. The equivalent full load hours (determined by dividing the total annual consumption by the total input power) for elevators is 8,772 hours/year. This is unexpectedly high given the anticipated schedule of operation for the project. Ensure that the models reflect the anticipated schedule of operation for the building. Refer to the ASHRAE 90.1-2007 User's Manual Table G-I for typical schedules for office occupancy. After making any necessary changes to the model, provide a narrative justifying the equivalent full load hours of operation for elevators.

Verify that the Baseline Case is modeled consistent with G3.1.1. Revise the model, prerequisite form, and supporting documents as required.
- 11. The space cooling energy consumption for both the Baseline and Proposed Cases appears to be lower than expected for a building in this climate zone. Review the Baseline inputs for the model to confirm that they conform to ASHRAE 90.1-2007 and LEED modeling protocol. Provide sufficient information regarding the energy inputs in the Section 1.4 Tables and an accompanying narrative to justify the reported energy consumption. Additionally, provide input summary reports to justify that the energy inputs correctly reflect ASHRAE 90.1-2007 and LEED modeling protocol.
