On November 2 & 3, 2013, the City of Palm Coast will host the 4th Annual Seafood Festival from noon to 5 p.m. each day at Central Park in Town Center. I would like to invite you, as one of our local restaurant or market owners to consider participation.

The Palm Coast Seafood Festival in partnership with Flagler Broadcasting combines a culinary celebration of seafood delights with a weekend of fun. The annual event will showcase the delights of the sea from a variety of local and regional restaurants and vendors, arts and crafts booths, Children's Village, along with musicians from around the area.

The City has made a significant change to this year's event — we have eliminated the event entrance fee to make the event more affordable to visitors and guests. We now estimate an attendance of at least 3,000 guests. Participation as a food vendor will give you the opportunity to sell food items and non-alcoholic beverages, plus receive the added benefit of exposing our attendees to your place of business. Food and/or beverage vendors are charged a nominal participation fee (\$150) and are required to submit a Certificate of Liability Insurance. The food and/or beverage vendor participation fee (\$150) is required when the application is submitted and all revenues collected at the event from the sale of your product(s) are yours to keep.

The Seafood Festival will be widely publicized including advertising on local and regional radio stations, in area newspapers, the City's newsletter, websites and social media, on posters and fliers, Bright House communications and the City's TV199!

To be considered as a vendor, please complete the enclosed event application and return with your payment so it is received by Friday, October 11, 2013. We are limiting the number of food/beverage vendors, so please mail or deliver your application as soon as possible to the Palm Coast Parks & Recreation Department, 305 Palm Coast Parkway NE, Palm Coast, FL 32137.
