[Section] Registration of Abandoned Real Property: Any owner of residential vacant property, or owner of any property that has suffered damage or destruction from a fire, flood, storm, or similar event that rendered the building incapable of being occupied, or any Mortgagee who holds a mortgage on real property must perform an inspection on the property. If the property is found to be vacant or shows signs of vacancy, it will be considered abandoned and the owner/mortgagee must register the property with the City of Palm Coast Code Enforcement. <i>An annual registration form is required for <u>each</u> vacant property.</i>					
2.	The owner, operator, or other person in control of a vacant building, or an authorized agent, must be able to arrive at the premises within one hour after a contact person named under this section is notified by the City or emergency response personnel that an emergency condition has occurred on the premises. Any person or corporation that has registered must report any change of information to the City of Palm Coast Code Enforcement within ten (10) days of the change.					
3.	[Section] Maintenance and Security Requirements. Properties shall be maintained and secured in accordance with the City of Palm Coast Municipal Code.
